The BAC will use a non- discretionary pass/fail criteria in the Eligibility Checks/ Screening as well as the Preliminary Examination of the Bid. The BAC will conduct post- qualification of the lowest calculated bidder.

All particulars to Eligibility Statement and Screening, Bid Security, Performance Security, Pre –Bidder Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by pertinent provisions of R.A. 9184 and its implementing rules and regulations.
