The Provincial Government of Palawan through the Bids and awards Committee (BAC) invites contractors who have been, registered with and classified by the Philippine Contractors Accreditation Board (PCAB), to apply for eligibility and if found eligible, to participate in the bidding for the following infrastructure projects:

Prospective bidder should possess a **valid PCAB License applicable to the contract**, have completed a similar contract with a value of at least **50% of ABC**, and have key personnel and equipment (listed in eligibility forms) available for the prosecution of the contract. The BAC will use a non- discretionary pass/fail criteria in the Eligibility Checks/ Screening as well as the Preliminary Examination of the Bid. The BAC will conduct post- qualification of the lowest calculated bidder.

All particulars to Eligibility Statement and Screening, Bid Security, Performance Security, Pre –Bidder Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by pertinent provisions of R.A. 9184 and its implementing rules and regulations.
